

2024 Night Market Vendor Application

TNDF's Night Market is a community gathering that provides food, arts, culture, and vibrancy to our community, inviting all people to learn, socialize, and support local. The Night Market is held at 16 York Street, Cannington on the last Tuesday of the month from May-September, 5 PM – 7 PM.

VENDOR APPLICATION PROCESS

The Night Market is organized in partnership between the Markets and Fundraising and Advocacy teams. The Market Coordinator is responsible for logistics and is the primary contact for vendors:

To be considered as a vendor for the 2024 Night Market, you must submit an application. To complete an application, please:

- ⇒ Read the Vendor Application thoroughly, including all rules and responsibilities.
- ⇒ Complete pages 4-6 and include a copy of insurance (if applicable)
- ⇒ Complete Durham Region Community Special Events Application (For Food Vendors) form (if applicable)
- ⇒ Submit your application by mail, email or by dropping off at our main office (16 York St., Cannington)

Vendors will be considered on a first come, first served basis. TNDF will create a waitlist if the number of vendors or the threshold for a particular type of vendor has been met.



FEES*

We are proud to offer vendor fees on a sliding scale payment model, meaning that vendors selected to participate will pay an amount per Night Market date to The Nourish and Develop Foundation, depending on their financial capacity. This fee varies from \$10 to \$50, with subsidized spaces available. Payments can be made by cheque, e-transfer, and cash, by 4 PM on each Night Market date. Vendor fees will not be refunded.

This model ensures that vendors of all income levels have equal opportunity to participate in the Night Market. Additionally, we encourage our vendors to 'pay it forward' by donating an extra amount towards supporting subsidized spots (recommended \$10). This initiative helps us to continue supporting the local community and providing an empowering experience for entrepreneurs who attend the Night Market.

All vendor fees received go directly towards supporting our community programs, including (but not limited to) our food bank, children's workshops, and transitional housing. Thank you for helping us nourish lives and develop change!

SPACE

Vendors are asked to provide an estimated amount of space needed up to 10'x10'. TNDF will assign a designated space prior to Night Market date. TNDF cannot guarantee access to power; but if it is required, please inform the Markets Coordinator.

Vendors shall not block walkways or fire exits or other Vendors' stalls.

Vendors are responsible for always keeping their stall area neat and clean. At the end of the Market, the Vendor is required to remove everything from their space.

SET UP & TEAR DOWN

Vendors will have access to their space one hour before the start of the Market for set up so they can be ready 15 minutes before.

Vehicles must be escorted in and out of our parking lot and must leave the parking lot no later than 4:30 PM. Public parking is available behind the Home Hardware store in Cannington and drop-offs can be made along York Street. Vendors must be 'open' by 4:30PM. Teardown begins NO EARLIER than 7PM.

PERMITS AND LIABILITY INSURANCE COVERAGE

TNDF insures the Market site located on its property. Vendors are responsible for obtaining all permits required in the production and sale of their goods and are responsible for securing additional insurance needed to cover risk.

All food vendors must fill out and return the *Durham Region Community Special Events Application* (For Food Vendors) form. It is your responsibility to comply with Durham Health Department rules. All items or ingredients prepared outside of the Market considered 'Potentially Hazardous Foods' by Durham Region Health must be prepared in an inspected kitchen. All food vendors must have thermometers for both cooked food, and for refrigeration.

TNDF will need a copy of each vendor's Liability Insurance Coverage if you have it.

CANCELLATIONS & ABSENCES

Cancellations will be decided by 2 PM on market day. Vendors must notify the Markets Coordinator of any intended absences at least 1 week prior to the Night Market date. If notification of absence is not received, the vendor forfeits their space and may be subject to refusal at following Night Markets.

Vendor feedback regarding the operation of the Market shall be directed to the Market Coordinator. Vendors and their staff and TNDF staff are responsible for being civil, honest, cooperative, and respectful with other Vendors, Market attendees, and the public more generally.
